Collection of manuscript material transferred from printed Theses collection 1637-late 19<sup>th</sup> century, mostly consisting of German academic material but including a small cache of 19<sup>th</sup> century Scottish legal papers, in which is an account of the death of a child chimney sweep in Edinburgh in 1817.

1. Oratio de prudentia by John James Federb, Ratisbon, 1636
2. Item formerly inserted in Jacobus A. Sceffer *Dissertation Politica II de II maiestate regia* Hardevic, 1648, pressmark: Th.S.17-4(19). It contains notes to the text.
3. MS continuation of Act of Scottish Parliament anent Excise, ?1645, taken from a pamphlet volume
4. German sermons, 1608, by Johann Zimmermann
5. Notebook , 1816, possibly of Ian W Ross, contains legal and business notes and brief notes of trip to Ireland
6. Students notebook of reading, possibly of a John Frances, 19<sup>th</sup> century
7. Notes on 17<sup>th</sup> and 18<sup>th</sup> century European academics, 18<sup>th</sup> century, with Latin contents list
8. Scottish Legal notes late 18<sup>th</sup> century
9. Notebook, Scottish legal notes late 18<sup>th</sup> century
10. German text apparently dedicated to William of Orange (possibly a poem on Namur)
11. Later copy, ? 18<sup>th</sup> century of Latin poem on Charlemagne by Matthew Borbon Caesar, Professor of Greek at Leipzig 1595, with extract from 14<sup>th</sup> century manuscript, 1399, describing an 'idol of the Teutons'
12. German theological/church historical work, ?17<sup>th</sup> century
13. Epitaph, 1541 of Philip Theophrastus of Salzburg
14. German 18<sup>th</sup> or 19<sup>th</sup> century manuscript – possibly poetry
15. Proaemium (Forward) recited by Johan Frederick Gebbard, Ratisbon, 21 March 1629.
16. Miscellaneous Latin theses, 18<sup>th</sup> or 19<sup>th</sup> century probably from German Univeristy Theses

17. Miscellaneous 18<sup>th</sup> and 19<sup>th</sup> century German material, probably from German University Theses, including an account of a comet at Ratisbon, 1680
18. Indictment, 1768, against John Bourke, tinker in Balligrant, Islay and members of this family for assault and battery
19. Copy letter, 1809 Mr Thomas Yorstoun to Mr Tait, concerning case of the minister of Kirkconnel
20. Declaration, 1816, of William Hogg, Newbyres, concerning stolen guns
21. Declaration of Joseph Rae and Robert Reid and Surgeon's report on the death in a chimney of John Thomson a nine year old chimney sweep, with surgeon's report.
22. Declaration, 1839, Of George Henderson, Thurso in a theft case
23. Miscellaneous 18<sup>th</sup>-19<sup>th</sup> century legal documents and legal notes concerning the sequestration of Richard Dennistoun, case, 1867 against the Caledonian brewery company, Wightman vs Beveridge, 1860
