1. Public relations costs

The National Library of Scotland is committed to making its world class collections accessible to as many people as possible. By doing so, we support education, research, business and innovation and help to enhance the reputation of Scotland as a country with a rich cultural heritage and a vibrant future. Like most organisations, NLS sees the media as an important means of communicating information to a wide audience. We work with journalists across Scotland and beyond to promote our general work, exhibitions and events. We also use social media such as Twitter and Facebook to reach people with information.

Listening to people who use our services is vital in helping us meet their needs. We carry out regular surveys of users' experiences to help us tailor our services. This provides evidence of the Library's performance and is reported to the Scottish Government. We also track and analyse media coverage of issues of relevance to the Library to inform and support our work.

We run an annual series of events at the Library and in other parts of Scotland which have proved popular. We also sponsor specific events at book festivals across Scotland. NLS's flagship publication is our award-winning 'Discover NLS' magazine which is published three times a year as well as being made available via our website. We also publish a newsletter and a range of information leaflets to communicate what is happening at the Library and how to use our services.

The amounts disclosed in relation to public relations include the amounts spent on media relations, marketing research and evaluation, promotional events and sponsorship, publications and printing, advertising digital marketing and staff.

The following are not defined in the guidance as constituting external consultancy: technical or specialist service (including construction, infrastructure and transport, IT, etc.); outsourcing; interim management / staff substitution; permanent recruitment services and advice.

7. Statement on the steps taken to promote and increase sustainable growth through the exercise of our functions.

The National Library of Scotland continued to develop its collections and services during 2013/14 to support the Scottish Government's aim of creating a more prosperous and successful country.

The Business Information Service continues to support business growth and development throughout Scotland by providing companies with access to information and knowledge they need.

We want to make more of the collection available electronically and have agreed a new contract to digitise more material including Gaelic books, Army lists covering WWI, trade directories, antiquarian Scottish books and printed music collections. This will add a further 1.2 million pages to our existing digitised content.

Digitisation delivers greater access. In the last three years we have had one million downloads of the 5,000 books we have digitised from our own collections.

8. Statement on the steps taken to improve efficiency, effectiveness and economy in the exercise of our functions.

The collaboration with the National Galleries of Scotland to create shared back office services continued. A pilot managed service is in place for NLS to deliver HR services to both organisations was introduced during 2013.

Work progressed on a new pay system which is essential to ensure that NLS is operating at maximum efficiency, given the difficult economic climate facing all public services.

During 2010 the Library committed to reduce CO2 emissions from its operations by 30% by the end of financial year 2014/2015 from 2008/09 levels. The Library exceeded this commitment during 2013/2014, achieving a reduction in CO2 emissions of 42% compared to its baseline year.

The Library now uses 3.1MwH less energy, consumes 3,568 cubic metres less water, recycles 22% more waste and travels 186,000 fewer miles than it did four years ago.

The NLS Public Sector Sustainability Report 2013-2014 provides comprehensive data relating to the Library's sustainability activity.

Our Attendance Management policy has successfully kept levels of absence to below the national average.
