Scottish Library and Information Council History

The Scottish Library and Information Council (SLIC) is the independent advisory body to the Scottish Government on library and information services. The Council was established in 1991 to create an organisation to support and lead strategic development for all library and information services in Scotland. Prior to 1991 it was The Library and Information Services Council (Scotland) (LISC(S)), founded in 1982, which advised Scottish Government on library and information services, before the establishment of SLIC.

Scope and Content

The Archive contains the minutes, committee papers, working group papers and reports produced by LISC(S) and its successor SLIC from 1982-2011. Although the organisation dates from 1982 there are papers relating to its creation between 1979 and 1982. There are a number of papers which relate to LISC partners in Northern Ireland and Wales. There are several files which relate to the restructuring of LISC(S) into SLIC. Also included are Conference materials and newsletters generated by the two organisations.

Arrangement

The Accession originally came with materials from the Scottish Library Association (SLA) and The Chartered Institute of Library and Information Professionals in Scotland (CILIPS). These materials were removed to become Acc.13656.

The original order of the minutes and committee papers has been maintained by adding the materials from their original folders into manuscripts folders. The working group papers and reports have been arranged chronologically, but in instances where there is the same start date, the group with the shortest duration appears first. The original working group papers were in designated folders and this order has been maintained in their transfer to manuscript folders.

A small number of papers held by SLIC but not part of their minutes, correspondence, committee papers, working group papers and reports, have been added to the SLIC Miscellaneous papers section at the end of the archive.
